induced visions (even if none of his friends did). He explored the self-actualization movements of the 1970s (and the self-indulgence that they produced), and since then has turned an increasingly skeptical eye toward the politicians and televangelists who don the cloak of religious rectitude to mask their own moral hypocrisy. What he learned along the way about the inconsistencies and peculiarities of religion infuriated Black, and in *Me of Little Faith* he gives full vent to his comedic rage. Black explores how the rules and constraints of religion have affected his life and the lives of us all. Hilarious experiences with rabbis, Mormons, gurus, psychics, and even the joy of a perfect round of golf give Black the chance to expound upon what we believe and why—in the language of a shock jock and with the heart of an iconoclast. "To put it as simply as I can," Black writes, "this is a book about my relationship with religion, where my—dare I say it?—spiritual journey has taken me...what it's meant and not meant to me, and why it makes me laugh." The scroll provides evidence of important cultural and spiritual relations between two peoples living together in the same land, Romanians and Jews, as well as two noted scholars of the time, Dosoftei, the Romanian archbishop, and the cabalist Nathan Nata Hanover, rabbi for over fifteen years (1657-1673) of the Jewish community in Iași, the capital city of the principality of Moldavia. This book includes a full-color reproduction of this manuscript, along with a comprehensive discussion of the origin and significance of this unique piece of Jewish Art.

**A History of Jewish Gynaecological Texts in the Middle Ages** - Rôn Barqây 1998

Later she joined the faculty of Temple University Medical School where, upon her retirement in 1987, she became Professor Emerita. She was recognized as "Woman Physician of the Year" by a Gold Medicus award of the Polish American Society in 1977 and received the Papanicolaou Award of the American Society of Cytology in 1985.
