AFTER 1866 THE TRADITIONAL ELITES WANTED TO AVOID FUNDAMENTAL CHANGES IN SOCIETY, EXPECTING A VICTORIOUS WAR TO SECURE THEIR OWN POSITION AT HOME AND TO BROADEN THE EUROPEAN BASE OF THE GERMAN REICH. IN THE FACE OF WORKING-CLASS HOSTILITY, THESE ELITES WERE UNABLE TO MOBILIZE MASS SUPPORT FOR THEIR INTERESTS, BUT HITLER FASHIONED A MASS PARTY. THE ALLIANCE BETWEEN THESE UNEQUAL PARTNERS LED TO THE THIRD REICH BUT WITH ITS COLLAPSE IN 1945 THE PRUSSO-GERMAN REICH CAME TO AN END. ONLY WITH THE GERMAN FEDERAL REPUBLIC DID THE LIBERAL-DEMOCRATIC TRADITIONS OF GERMAN HISTORY AGAIN COME INTO THEIR OWN.
