This is also because constant changes in international and domestic circumstances impinge on the management and analysis of South Africa's foreign policy. This, the first

Strategic Theory for the 21st Century: The Little Book on Big Strategy - Dr. Harry R. Yarger 2006

Strategy for the nation-state is neither simple nor easy. Good strategy demands much of the military professional whether he is formulating, articulating, evaluating, or executing strategy. Few do it well. It requires the professional to step out of the planning mind set and adopt one more suited for the strategic environment. This is particularly true in periods of great change and turmoil when a successful military strategy must be closely integrated with and may depend on other national strategies of the interagency community. A theory of strategy helps in this transition by educating the professional and disciplining his thinking in any of his roles. Mozambique's foreign policy towards South Africa - Paulo Mateus Wache 2022-07-20

This Book discusses the Mozambique's foreign policy framework in general, and towards South Africa, in particular, searching to understand why it has been characterized by the hostility-friendship dichotomy. The Book argues that asymmetry alone cannot explain the occurrence of the dichotomy as suggested by Womack's asymmetry theory. In the case of Mozambique's foreign policy, the dichotomy is caused by combination of factors namely: power asymmetry, ideological differences, leadership perceptions, economic disagreements and economic ties. However, it is highlighted that power asymmetry is the main factor of the dichotomy. This complexity and amalgamations of causes of the dichotomy makes it a permanent and distinctive feature of Mozambique's foreign policy towards South Africa. Thus, the major contribution of this book is twofold. First, it presents a detailed and comprehensive analysis of Mozambique's foreign affairs as they have interacted with South Africa. Second, by applying asymmetry theory to Mozambique the study makes a significant theoretical contribution to understanding the agency of the smaller side in bilateral asymmetric relationships.

Prioritization Theory and Defensive Foreign Policy - Hanna Samir Kassab 2017-02-07

This book studies systemic vulnerabilities and their impact on states and individual survival. The author theorizes that the structure of the international system is a product of the distribution of capabilities and vulnerabilities across states. States function or behave in terms of these systemic threats. The author examines a number of specific case-studies focusing on military, economic, environmental, political and cyber vulnerabilities, and how different states are impacted by them. Arguing that current attempts to securitize these vulnerabilities through defensive foreign policies are largely failing, the book makes the case for prioritizing economic development and human security.

Egyptian Foreign Relations Under al-Sisi - Christian Achraimer 2022-09-28

Considering both changes and continuities, this book examines how, why, and along which lines Egypt's external alignments under the al-Sisi regime emerged and developed. Egypt's foreign relations have changed substantially since the current regime took power in 2013. To assess this, the author develops and applies a unique analytical approach: the model of 'two-staged alignment formation.' In the first stage, domestic threats to the Egyptian regime's survival determined specific needs the regime tried to meet by approaching external partners. In the second stage, characteristics of the global and regional environments defined opportunities and constraints and therefore the regime's options and logical choices. In sum, the interplay of developments on the domestic, regional, and global levels resulted in a diversification of Egypt's external alignments, with China and Russia joining the EU and the US as Egypt's main global partners, and Saudi Arabia and the United Arab Emirates emerging as the regime's prime regional partners. Explaining the emerging alignment patterns from 2013 until 2017, this book aids understanding of the complexity of alignment formation and of Egyptian external relations in that critical period of time. This book will be of high interest to researchers and students working on Egyptian foreign relations, on relations between states, and on regional dynamics in the West Asia and North Africa (WANA) region. It is also valuable for practitioners, because it helps to understand an issue of high relevance for foreign policy-making.

The EU, along with the US, UN and Russia, not only gave its support to Fatah against Hamas, but also imposed a tough siege on the Hamas government in an attempt to force it to accept the Quartet's political conditions, described by Hamas leaders as unfair and impossible. Many observers are convinced that the EU's behaviour in this matter has been unreasonable and has conflicted with the EU's own democratic beliefs and values. This book sheds light on the EU's policies in Palestine mainly from 2003- 2013, and provides a thorough examination of the inconsistencies and paradoxes in the EU discourse towards Hamas, and the determinants underlying such contradictions. It explores the reasons behind the EU labelling the Hamas a terrorist organization and discusses why the EU has boycotted its democratically elected body since 2006.

Significantly, the book looks at whether the EU jeopardized its reputation and

contravened its core normative values and objectives (democracy promotion, human rights, the rule of law and fundamental freedoms) by such a categorisation of Hamas. Exploring the EU's policy towards Hamas is vital for understanding how the relationship between the EU and the rest of the Islamists in the Middle East is perceived, as it enables both sides to have a cognitive basis upon which to construct better relations. This book, based upon a vast spread of primary EU documents and interviews, will therefore be a valuable resource for those studying the Arab Israeli conflict, Political Islamic movements, the Middle East Peace Process, and anyone with an interest in European Union Foreign Policy.

European Security Governance and the European Neighbourhood after the Lisbon Treaty - Christian Kaunert 2013-09-13

The EU has often been considered to be a weak security actor. However, any assessment of the EU's role in international security is underpinned by a specific understanding of security. This book is based on a broad understanding of security. We consider that security concerns are increasingly triggered by challenges such as terrorism, climate change, mass migration flows, and many other 'non-traditional' security issues.
