A Handbook of Global Freshwater Invasive Species - Robert A. Francis 2017-08-11

Invasive non-native species are a major threat to global biodiversity. Often introduced accidentally through international travel or trade, they invade and colonize new habitats, often with devastating consequences for the local flora and fauna.
