The Man Who Broke Into Auschwitz - Denis Avey 2012-09-11

The Man Who Broke into Auschwitz is the extraordinary true story of a British soldier who marched willingly into the concentration camp, Buna-Monowitz, known as Auschwitz III. In the summer of 1944, Denis Avey was being held in a British POW labour camp, E715, near Auschwitz III. He had heard of the brutality meted out to the prisoners there and he was determined to witness what he could. He hatched a plan to swap places with a Jewish inmate and smuggled himself into his sector of the camp. He spent the night there on two occasions and experienced at first-hand the cruelty of a place where slave workers, had

been sentenced to death through labor. Astonishingly, he survived to witness the aftermath of the Death March where thousands of prisoners were murdered by the Nazis as the Soviet Army advanced. After his own long trek right across central Europe he was repatriated to Britain. For decades he couldn't bring himself to revisit the past that haunted his dreams, but now Denis Avey feels able to tell the full story—a tale as gripping as it is moving—which offers us a unique insight into the mind of an ordinary man whose moral and physical courage are almost beyond belief.

Reckonings - Mary Fulbrook 2018
A single word - "Auschwitz" - is sometimes used to encapsulate the totality of persecution and suffering involved in what we call the Holocaust. Yet focusing on a single concentration camp, however horrific the scale of crimes committed there, leaves an incomplete story, truncates a complex history and obscures the continuing legacies of Nazi crimes. Mary Fulbrook's encompassing book explores the lives of individuals across a full spectrum of suffering and guilt, each one capturing one small part of the greater story. Using "reckoning" in the widest possible sense to evoke how the consequences of violence have expanded almost infinitely through time, from early brutality through programs to euthanize the sick and infirm in the 1930s to the full functioning of the death camps in the early 1940s, and across the post-war decades of selective confrontation with perpetrators and ever-expanding commemoration of victims, Fulbrook exposes the disjuncture between official myths about "dealing with the past" and the extent to which the vast majority of Nazi perpetrators evaded responsibility. In the successor

states to the Third Reich - East Germany, West Germany, and Austria - prosecution varied widely. Communist East Germany pursued Nazi criminals and handed down severe sentences; West Germany, caught between facing up to the past and seeking to draw a line under it, tended toward selective justice and reintegration of former Nazis; and Austria made nearly no reckoning at all until the mid-1980s, when news broke about Austrian presidential candidate Kurt Waldheim's past. The continuing battle with the legacies of Nazism in the private sphere was often at odds with public remembrance and memorials. Following the various phases of trials and testimonies, from those immediately after the war to those that stretched into the decades following, *Reckonings* illuminates shifting public attitudes toward both perpetrators and survivors, and recalibrates anew the scales of justice.

McKale's book stands out, not only for the detailed review of the war crimes of innumerable Nazis, but because he also chronicles their lives in the years following WWII. The book is graphic and the memories of survivors are painful to absorb, as one prisoner describes a concentration camp like "Dante's inferno...come to life," while another recounts mass executions in the gas chamber. McKale uncovers a recurring theme of denial during criminal trials: Dr. Warner Best

insisted that the first time he heard about the killing of 5-6 million Jews was in the courtroom and Josef Kramer claimed, "I did not know the purpose of the gas chamber." But it's the enduring anti-Semitic attitude that resounds throughout the book; many war criminals went unpunished in the years following WWII. Even Adolf Eichmann, one of the most infamous Nazi criminals, went free for nearly 20 years, escaping Germany through a well-established "rat line." McKale ends the book with a haunting question: whether life would be different today if the Allies had pursued Holocaust criminals more aggressively after WWII. History buffs and students of the Holocaust will be fascinated with this book but for the casual reader, there's an enormous amount of material to digest—probably too much—and the graphic descriptions will likely prove overwhelming. SS Einsatzgruppen - Gerry van Tonder

In June 1941, Adolf Hitler, whose loathing of Slavs and Jewish Bolsheviks knew no bounds, launched Operation Barbarossa, throwing 4 million troops, supported by tanks, artillery and aircraft into the Soviet Union. Operational groups of the German Security Service, SD, followed into the Baltic and the Black Sea areas. Their orders: neutralize elements hostile to Nazi domination. Combined SS and SD headquarters were set up in Riga (northern), Mogilev (middle) and Kiev (southern), each with subordinate units of the SD, the Einsatzgruppen, and lower echelons of Einsatzkommandos. Communist and Soviet NKVD (Peoples Commissariat for Internal Affairs) agents were targeted, and from August 1941 to March 1943, 4,000 Soviet and communist agents were arrested and executed. In addition, far greater

numbers of partisans and communists were shot to ensure political and ethnic purity in the occupied territories. Einsatzgruppe A, under Adolf Eichmann, executed 29,000 people listed as Jews or mostly Jews in Latvia and Lithuania in the early stages of the operation. In the Einsatzgruppe C report for September 1941, there is a comment, 50,000 executions foreseen in Kiev. In five months in 1941, Einsatzkommando III commander, Karl Jger, reported killing 138,272 (48,252 men, 55,556 women and 34,464 children). The Einsatzgruppen were death squads their tools the rifle, the pistol and the machine gun. It is estimated that the Einsatzgruppen executed more than 2 million people between 1941 and 1945, including 1.3 million Jews.

Hitler's Secret Weapons - David Porter

Rudolf Hoss has been called the greatest mass murderer in history. As the longest-serving commandant of Auschwitz, he supervised the killing of more than 1.1 million people. Unlike many of his Nazi colleagues who denied either knowing about or participating in the Holocaust, Hoss remorselessly admitted, both at the Nuremberg war crimes trial and in his memoirs, that he sent hundreds of thousands of Jews to their deaths in the gas chambers, frankly describing the killing process. In KL, Wachsmann fills this glaring gap in our understanding. He not only synthesizes a new generation of scholarly work, much of it untranslated and unknown outside of Germany, but also presents startling revelations, based on many years of archival research, about the functioning and scope of the camp system. Examining, close up, life and death inside the camps, and adopting a wider lens to show how the camp system was shaped by changing political, legal, social, economic, and military forces, Wachsmann produces a unified picture of the Nazi regime and its camps that we have never seen before. A boldly ambitious work of deep importance, KL is destined to be a classic in the

history of the twentieth century.

The Theory and Practice of Hell - Eugen Kogon 2006-09-19
By the spring of 1945, the Second World War was drawing to a close in Europe. Allied troops were sweeping through Nazi Germany and discovering the atrocities of SS concentration camps. The first to be reached intact was Buchenwald, in central Germany. American soldiers struggled to make sense of the shocking scenes they witnessed inside. They asked a small group of former inmates to draft a report on the camp. It was led by Eugen Kogon, a German political prisoner who had been an inmate since 1939. *The Theory and Practice of Hell* is his classic account of life inside. Unlike many other books by survivors who published immediately after the war, *The Theory and Practice of Hell* is more than a personal account. It is a horrific examination of life and death inside a Nazi concentration camp, a brutal world of a state within state, and a society without law. But Kogon maintains a dispassionate and critical perspective. He tries to understand how the camp works, to uncover its structure and social organization. He knew that the book would shock some readers and provide others with gruesome fascination. But he firmly believed that he had to show the camp in honest, unflinching detail. The result is a unique historical document—a complete picture of the society, morality, and politics that fueled the systematic

torture of six million human beings. For many years, *The Theory and Practice of Hell* remained the seminal work on the concentration camps, particularly in Germany. Reissued with an introduction by Nikolaus Waschmann, a leading Holocaust scholar and author of *Hilter's Prisons*, this important work now demands to be re-read.

Ravensbruck - Sarah Helm 2015-03-31
A masterly and moving account of the most horrific hidden atrocity of World War II: Ravensbrück, the only Nazi concentration camp built for women. On a sunny morning in May 1939 a phalanx of 867 women—housewives, doctors, opera singers, politicians, prostitutes—was marched through the woods fifty miles north of Berlin, driven on past a shining lake, then herded in through giant gates. Whipping and kicking them were scores of German women guards. Their destination was Ravensbrück, a concentration camp designed specifically for women by Heinrich Himmler, prime architect of the Holocaust. By the end of the war 130,000 women from more than twenty different European countries had been imprisoned there; among the prominent names were Geneviève de Gaulle, General de Gaulle's niece, and Gemma La Guardia Gluck, sister of the wartime mayor of New York. Only a small number of these women were Jewish; Ravensbrück was largely a place for the Nazis to eliminate other inferior beings—social outcasts, Gypsies, political enemies, foreign resisters, the sick, the disabled, and the “mad.” Over six years the prisoners endured beatings, torture, slave labor, starvation, and random execution. In the final months of the war, Ravensbrück became an extermination camp. Estimates of the final death toll by April 1945 have ranged from 30,000 to 90,000. For decades the story of Ravensbrück was

hidden behind the Iron Curtain, and today it is still little known. Using testimony unearthed since the end of the Cold War and interviews with survivors who have never talked before, Sarah Helm has ventured into the heart of the camp, demonstrating for the reader in riveting detail how easily and quickly the unthinkable horror evolved. Far more than a catalog of atrocities, however, Ravensbrück is also a compelling account of what one survivor called "the heroism, superhuman tenacity, and exceptional willpower to survive." For every prisoner whose strength failed, another found the will to resist through acts of self-sacrifice and friendship, as well as sabotage, protest, and escape. While the core of this book is told from inside the camp, the story also sheds new light on the evolution of the wider genocide, the impotence of the world to respond, and Himmler's final attempt to seek a separate peace with the Allies using the women of Ravensbrück as a bargaining chip. Chilling, inspiring, and deeply unsettling, Ravensbrück is a groundbreaking work of historical investigation. With rare clarity, it reminds us of the capacity of humankind both for bestial cruelty and for courage against all odds.

Surviving the Angel of Death - Eva Kor 2012-03-13

Describes the life of Eva Mozes and her twin sister Miriam as they were interred at the Auschwitz concentration camp during the Holocaust, where Dr. Josef Mengele performed sadistic medical experiments on them until their release.

The Nazis Knew My Name - Magda Hellinger 2022-03-15

Through her inner strength and shrewd survival instincts, she was able to rise above the horror and cruelty of the camps and build pivotal relationships with the women under her watch, and even some of Auschwitz's most notorious Nazi senior officers. A Judge in Auschwitz - Kevin Prenger

In autumn 1943, SS judge Konrad Morgen visited Auschwitz concentration camp to investigate an intercepted parcel containing gold sent from the camp. While there Morgen found the SS camp guards engaged in widespread theft and corruption. Worse, Morgen also discovered that inmates were being killed without authority from the SS leadership. While millions of Jews were being exterminated under the Final Solution programme, Konrad Morgen set about gathering evidence of these 'illegal murders'. Morgen also visited other camps such as Buchenwald where he had the notorious camp commandant Karl Koch and Ilse, his sadistic spouse, arrested and charged. Found guilty by an SS court, Koch was sentenced to death. Remarkably, the apparently fearless SS judge also tried to prosecute other Nazi criminals including Waffen-SS commanders Oskar Dirlewanger and Hermann Fegelein and Auschwitz Commandant Rudolf Höss. He even claimed to have tried to indict Adolf Eichmann, who was responsible for organising the mass deportation of the Jews to the extermination camps. This intriguing work reveals how the lines between justice and injustice became blurred in the Third Reich. As well as describing the actions of this often contradictory character the author questions Morgen's motives.

Auschwitz - Laurence Rees 2006-01-10

Death Dealer - Rudolf Hoss 2012-08-31

Rudolf Höss was history's greatest mass murderer, having personally supervised the extermination of approximately two million people, mostly Jews, at the death camp in Auschwitz, Poland. *Death Dealer* is the first complete translation of Höss's memoirs into English. These bone-chilling memoirs were written between October 1946 and April 1947. At the suggestion of Professor Stanislaw Batawia, a psychologist, and Professor Jan Shen, the prosecuting attorney for the Polish War Crimes Commission in Warsaw, Höss wrote a lengthy and detailed description of how the camp developed, his impressions of the various personalities with whom he dealt, and even the extermination of millions in the gas chambers. This written testimony is perhaps the most important document attesting to the Holocaust, because it is the only candid, detailed, and (for the most part) honest description of the Final Solution from a high-ranking SS officer intimately involved in carrying out the plans of Hitler and Himmler. With the cold objectivity of a common hit-man, Höss chronicles the discovery of the most effective poison gas, and the technical obstacles that often thwarted his aim to kill as efficiently as possible. Staring at the horror without reacting, Höss allowed conditions at Auschwitz to reduce human beings to walking skeletons - then he labelled them as subhumans fit only to die. Readers will witness Höss's shallow rationalizations as he tries to balance his deeds with his increasingly disturbed, yet always ineffectual, conscience.
